#### **METHOD OF PAYMENT:**

Upon enrollment, the tuition is due and payable in full. However, at the option of the College, the student may pay (example is for full-time basis) the Registration Fee of \$100 and a down payment of \$870, then the balance to be spread over twelve (12) equal monthly installments (six (6) months for the 1000 hour full-time program) until the balance is paid in full. The College accepts payments including but not limited to, cash, money order, check, direct deposit, VA payment, and/or Title IV Pell Grant, if eligible.

## **ADDITIONAL CHARGES**

If a student must attend longer than the prescribed time allotted for his or her program of study in order to fulfill the hours required, a fee of \$8.22 per hour is assessed for every additional hour required to complete the program.

## **ADDITIONAL ENROLLMENT COSTS**

1. **PICTURES (STUDENT ID)** Students need two (2) pictures; they should be no less than 2½ x 3½ and no more than 3x5 in size. The College takes the student pictures; there is a \$20.00 fee for the pictures. Re-entry students are responsible for additional photo requirements charges, if applicable.
2. **SMOCK** (Estimated cost, \$30 to \$40 pending on size). Students must obtain the smock from the school. Smocks should be acquired by the first day of school; as to the requirement for students to wear smocks during school hours.

All students must have purchased the smock in order to take the required new student evaluation practical test and proceed on in school.

## **ADDITIONAL COSTS UPON GRADUATION:**

**The Ohio State Cosmetology and Barber Board Examination:** The initial examination fee is \$55.00 payable by credit card or by electronic check, then an additional \$30.00 for actual license. There is a \$3.50 processing fee on top of the license fee. The student is responsible for these expenses. The \$55.00 is required by the State Board and must be paid via the E-License portal at the time of registration and scheduling for the licensing examination. Note: the costs of \$55.00 and \$30.00 and \$3.50 fee are subject to change due to possible increases mandated by the State Board.

Also, there may be other costs related to travel to Dublin for the exam, (food, lodging, etc.)

### **Per ORC 4709.071 Temporary Pre-Examination Work Permit:**

- (A) The state cosmetology and barber board shall issue a temporary pre-examination work permit to practice barbering to an individual who applies for and is eligible to take an examination conducted under section 4709.07 of the Revised Code, if the individual satisfies all of the following conditions:
  - (1) The individual has not previously failed an examination conducted under section 4709.07 of the Revised Code.
  - (2) The individual pays the board the applicable fee.
  - (3) The individual satisfies all other conditions established by rules adopted under section 4709.05 of the Revised Code.
- (B) An individual issued a temporary pre-examination work permit under this section may practice barbering until the date the individual is scheduled to take an examination under section 4709.07 of the Revised Code. The individual shall practice under the supervision of an individual holding a current, valid barber license.
- (C) A temporary pre-examination work permit is renewable in accordance with rules adopted under section 4709.05 of the Revised Code.

It is the student's responsibility to complete the work permit form; it is filed and paid for via the E-License portal at the time of scheduling the licensure examination. It is an additional \$15.00 fee.
